1. Objectives and overview

1. Objectives of the Event

- Since 2008, the JSDA, in cooperation with the JFSA and the JPX, has hosted the Japan Securities Summit, an international promotion event of the Japanese market, encouraging foreign investors' investment, foreign companies' listing and foreign securities companies' and financial institution's entry to the market.
- Recognizing that overseas demand for information on the Japanese market remains high, and in cooperation and consultation with related parties, we would like to hold the 14th Japan Securities Summit in New York, a major global financial center, in 2025 for the first time in two years, in order to deepen the understanding of the Japanese economy and securities market among overseas investors and market participants.

2. Overview of the Japan Securities Summit

- 1) Date : March 3rd, 2025
- 2) Venue : **Japan Society, New York, the United States**
- 3) Main objectives :
 - ① To introduce the economic outlook, stock market trends, and growth strategies of Japan to the US institutional investors and other market professionals
 - ② To provide participants from Japan with an opportunity to directly obtain local information on the trends of local institutional investors, the current state of the securities business, securities regulations and their impact on the securities business.
 - ③ To enhance the linkages between the US and Japanese securities markets/industries through dialogue among market participants

2. Topics, participants and supporters

4) Major topics

Examples of possible topics at this moment are as follows.

- Japanese economy (macroeconomic situation, monetary and fiscal policies, response to social issues, etc.)
- Stock market (market situation, initiatives by the government, stock exchanges and corporates, etc.)

5) Expected Participants

U.S.-based securities companies / financial institutions, institutional investors, fund managers, government authorities, media, researchers at universities and think tanks

6) Host Organizations/Supporters

7) Others

We will hold a round table discussion with local market participants, visiting embassies, industry associations and stock exchanges, etc. to exchange information and opinions.

If there is sufficient demand, we will also consider organizing market tours etc. to exchange opinions with local market participants.
